## Impact

However, 90% say it’s challenging to make data available in a suitable format.<sup>2</sup>

Organisations pull data from an average of 400 sources to feed business insights, and over a third have to manually code data to get it into the needed format for analytics.<sup>2</sup> When information is stored on paper, it’s hard to find and can’t be easily accessed or quickly shared—especially with a remote workforce.

Data silos and the resulting data management inefficiencies impede insights and innovation.

A single non-compliance event can cost more than \$14 million.<sup>3</sup> But the cost of achieving compliance isn’t trivial. With labour costs making up 68% to 94% of the cost of regulatory compliance,<sup>4</sup> time-consuming and labour-intensive physical document management contributes significantly to annual costs of up to \$31 million.<sup>5</sup>
